HISTORY RESEARCH AWARD 2016 - Fidelia Ibekwe-SanJuan (for future work with Thomas Dousa)

Information Science: Origins, theories & paradigms. A comparative approach.

The grant will enable the investigation of how the origins of IS as a discipline in France compare with those in five other European countries--England, Croatia, Spain, Italy, and Finland. Germany is mentioned as a sixth. The thesis that France has developed its own singular form of IS in the context of an entwined information and communication sciences is challenged. The title of the grant application is translated from their well-received book from 2012 in French, and this award extends the exploration of that successful historical and theoretical approach across Europe and in conjunction with many excellent colleagues across the continent. We congratulate the award winners for the international scope of their endeavor and wish them all good work.

HISTORY PAPER AWARD 2016 - Gabor Szommer

Parallel expansions: The role of information during the formative years of the English East India Company

Dr. Szommer is an independent researcher in Hungary, who has performed similar original economic investigations of the early years of the Dutch East India Company. Primary source materials lend a thoughtful and fascinating glimpse into shared navigational knowledge. The model posed is one of information aggregation (and loss!) amidst vast distances wherein nascent corporate decision-making necessarily relied upon incomplete and asynchronous reporting. The History Board commends Dr. Szommer for his historical perspective and detailed portraiture and hope this grant stimulates publication of an impressive study.
